Dear Parents and Guardians,

It is that time of year again when we begin the New York State testing administration for students in grades 3-8 in English Language Arts and mathematics. Our teachers have been preparing our students for the exams since the school year began with a comprehensive curriculum aligned to the Common Core Learning Standards. Students will be exposed to the testing format through various exercises over the next few weeks.

As you may already know, these exams have once again changed for the 2015-2016 administration. Some of the outlined changes include the following:

- Decrease in the number of test questions,
- A shift to **untimed** testing.

The English Language Arts testing will take place beginning on **Tuesday, April 5th**, and ends on **Thursday, April 7th**. On <u>each</u> of the three days of testing, students will be afforded unlimited time to complete each exam section. We anticipate emphasis on non-fiction text-based questions and multiple opportunities for children to respond to questions in writing.

The mathematics exam begins on **Wednesday, April 13th**, and ends on **Friday, April 15th**. Similar to the ELA, students will be afforded unlimited time to complete each section. On the first two days, all questions will be multiple choice and the third day will include short and extended response questions where students will be expected to show their work.

We recognize the students will be afforded unlimited time; however, as listed below the New York State Education Department has provided estimated times for which the exams should be completed. With that said, if students require more time beyond the "estimated" time, we will move these students to a separate testing location which will provide the child with the time needed to complete the exam. Children refusing exams will be brought back to class at the end of the "estimated" time period to continue with their instructional day. All children will have a snack break in the morning whether they are a test-taker or not.

Listed below are more detailed changes to the exams as compared to last year.

Upon receiving the results, which has typically been in August, we will provide you with a detailed report outlining the areas tested and the scores received. In addition, we anticipate 50% of the questions to be released; and once they are made available, we will share the link to this information with you.

The district does not encourage the refusal of the exams, especially in light of the new changes. However, we recognize this is a parent choice.
