There were approximately 50 district residents and staff members present.

Mr. Bettan called the meeting to order at 7:45 p.m.

The Pledge of Allegiance was recited.

Mr. Bettan welcomed everyone to this evening's Board of Education meeting. He thanked all our stakeholders for their support in passing both our 2011-2012 school budget and our capital reserve proposition by 65%. He read the letter that the Board of Education has put on its website thanking our teachers, staff, administrators, building and ground teams that keep our building up and running, our parents and the PTA who always advocate and fight for our children. The Board is grateful to everyone in our community who appreciates and values our public education system and our district.

Mr. Bettan stated that tonight the Board will act on tenure recommendations. Ms. Gierasch will present a report on our new elementary report card. She will also give an up date on MAP. He noted that MAP is a program that has had mixed results. We look forward to ideas and recommendations from the MAP committee on how to get it back on track. Mr. Jonas will be giving us an update on staffing. We will also have a report on possibly re-evaluating our hiatus from overnight field trips.

High School Representative Update

XXXXXXXX, our high school representative, updated the Board on events at the high school. Ms. XXXXXX presented the Board with a petition requesting students of the choir receive additional credit for their participation in Monday Night Choir.

Board Announcements

Mrs. Pierno stated that she, Mr. Bettan, Mrs. Schulman and Mr. Cepeda had the opportunity of visiting the Kindergarten Center last week. She saw great things being done with these children. They couldn't believe the type of work these kindergarten students were doing. They were very impressed. She thanked Ms. Leiboff and her staff.

Mrs. Rothman stated that she had the opportunity of attending the Art Expo at the Vision Gallery. She stated that the level of art work and projects were very sophisticated. She congratulated the students and thanked our teachers and staff for a outstanding event.

Mr. Cepeda stated that the Kindergarten Center visit brought Board Members a great deal of satisfaction. Visitations to schools by members of the Board are very worthwhile. We can see what the kids are doing and what they may need.

Mrs. Lieberman urged everyone to come out and support our Memorial Day Parade.

Mr. Bettan stated we will try to visit all the schools. To go into classrooms and to see lessons being taught is great. He noted that the Board will do their best to start visitations earlier next year.

Superintendent's Announcements

Mr. Dempsey thanked the community for its support of our budget. He noted we had a 65% approval vote. This is very encouraging. He spoke of the tax cap that is being pushed. He expressed his view that this is not the right way to go.

Mr. Dempsey spoke of major changes in the Education Department. Dr. John King has been named Commissioner of Education in very challenging times. He is very talented.

Mr. Dempsey stated that we have invited New York State Regent, Roger Tilles, to visit our school district. We are hoping to set this up.

Mr. Dempsey informed the community that we will be administering the survey on school climate. He also encouraged everyone to attend the Memorial Day Parade.

Mr. Jonas spoke of the Circle of Success at Mattlin Middle School. It was a terrific event.

Ms. Gierasch was very proud to announce that our 6th Grade Project Challenge Team at Plainview Middle School was selected as a second place National Wining team for their project, Blindsight. Ms. Gierasch explained that Blindsight, a device, in the form of a contact lens, is equipped with a nano-sized video camera that streams images to a microchip implanted in the occipital lobe of the brain, which is the control center for visual processing. Blindsight will perceive these images, in place of the brain. The members of the winning team are: Alexandra Fryman, Phillip Danziger, Sophie Heiman and Thomas Venezia.

Mr. Bettan congratulated these students on their very outstanding achievement.

Reports

1. <u>Elementary Report Cards</u>

Ms. Gierasch introduced the following four members of the committee that are here tonight to answer any questions by the Board: Alison Clark, Greg Scesney, Karen Bezzina and Brianna Hamrah.

Ms. Gierasch spoke of the reasons for updating the report cards: New curriculum across subject areas, Common Core Standards, communication of parents and Rtl regulations. She reviewed the process involved. They created a document that was teacher and parent friendly and articulated our current curriculum and student outcomes. Ms. Gierasch discussed what was the same and what was different. She reviewed trimester reporting. Ms. Gierasch noted that benchmark levels will be sent home separately via a district-wide form aligned with benchmarking dates.

Discussion:

Mrs. Lieberman discussed fluency. She asked how a child gets a three or how the child gets a five.

Ms. Gierasch responded.

Mrs. Lieberman wants sufficient information to be given out to the parents.

Ms. Gierasch stated there will be directions on the report card. She stated that it will be explained to the parents. There would be a Q and A going home to parents explaining the grades. We want to bring to the attention of the parents how well or not well a child is doing.

Mrs. Schulman asked about the survey for the parents. How did it get to the parents.

Ms. Gierasch stated it went home in the backpacks of the children.

Mrs. Schulman questioned the change from quarterly reporting to trimester reporting.

Ms. Gierasch stated we are giving information to parents on a more frequent and regular basis.

Mrs. Schulman asked if we got feedback from the parents on the switch.

Ms. Gierasch stated we have had no feedback back at this point.

Mrs. Rothman stated this report card is very beneficial. She noted that in other districts, there is a drop down for comments from teachers. Will we have that.

Ms. Gierasch stated we will look at this.

Mr. Cepeda reiterated that he wants this to be part of our infinite campus portal.

Mr. Jonas stated we are looking at a system that can accomplish this.

Mrs. Pierno asked if the comment section will be typed.

Mr. Bettan asked if we have given consideration to giving half grades which would show parents that improvement is occurring.

Ms. Clark stated we will use plus and minus.

Mrs. Bernstein expressed her view that the report card really looks good. When she reviewed the report card initially, she didn't understand what the boxes were for. Now after it was explained, it makes perfect sense. We need to work a little on making sure the directions are easy to understand.

Ms. Gierasch discussed social skills and work habits on the report card. She applauded the committee for all their work and effort.

Mrs. Pierno spoke of other performance measurements. Could these be included in the report cards.

Ms. Gierasch spoke of plans to send home a letter to parents. She discussed benchmarks.

Mr. Bettan asked if the benchmarks could be placed on line.

Mrs. Schulman expressed her views that she likes the idea of having this on line.

Ms. Gierasch discussed parent/teacher conferences. Report cards would go home and then we would have conferences. She stated there is a need for more time for each parent to speak to the teacher at the conference. She is recommending adding another half day conference right after the first half day conference.

Mrs. Bernstein asked what "optional" means for a parent to attend the last parent conference.

Mrs. Rothman stated she understands that another half day would give more time to parents. However, because a lot of parents work, this would present a problem for these parents.

Ms. Clark discussed the evening hours of the conferences.

Mrs. Bernstein stated that she wants to have parents input.

Mrs. Lieberman asked if any thought has been given to keeping the children in the building. Parents might not have child care.

Mrs. Lieberman expressed her views that parents should have more time with the teacher. Perhaps we could figure out a way to keep kids in school.

Mrs. Bernstein thanked the Committee for all their hard work. The report cards reflect our school climate goals.

Ms. Gierasch thanked all the members of the committee.

Mrs. Pierno stated that she wants to get feed back from parents.

Mrs. Lieberman also stated that the Board would like to hear comments from parents.

Mr. Bettan thanked all the teachers and staff for their work on the committee.

2. MAP

Ms. Gierasch introduced Mr. Dean Mittleman, Mr. John McNamara and Ms. Deanna Consiglio members of the MAP committee. She reviewed the work of the Committee.

Mr. Mittleman discussed the history of MAP. Ms. Consiglio discussed the goals of MAP. Ms. Gierasch quoted the present goals and the new language.

Mr. Cepeda applauds the work of the Committee. He asked how are we going to express consistency.

Mr. Mittleman stated we have to do a better job in letting parents know the expectations of MAP.

Mr. Cepeda stated we had an agreement previously with the PCT. He asked how are we going to have some general consistency in MAP. He has heard some classes are wonderful and some classes not so much.

Mr. McNamara discussed expectations and the make up of the group. You have to strike a balance.

Mrs. Schulman discussed the home/school connection. She has heard complaints that there is no home/school connection.

Mr. Mittleman discussed this. He stated that at the three week mark in the new school year, we will have a presentation for parents to meet MAP teachers and understand what MAP is.

Ms. Gierasch stated we want to get kids more involved.

Mrs. Lieberman stated that kids have to take ownership. She is glad we are trying to give this program a facelift.

Mr. McNamara stated it is the one place we are bringing all grades together.

Mrs. Pierno stated we need a one on one dialogue.

Mr. Mittleman stated there may be a contractual issue.

Ms. Gierasch stated parents can always call a teacher during the year.

Mr. McNamara spoke of the pilot program at Plainview Middle School offering 8th graders an opportunity to participate in MAP Leadership groups. He has received very positive feedback from students.

Mrs. Bernstein expressed her views that it is never too late to assess something and to make it work the way we originally envisioned it. She is really glad we are looking at it to make it better.

Mrs. Schulman stated that MAP has been in the district six years. We are going to be spending more time to try something. She is concerned that teachers are pressed for time. She wonders about the cost benefit ratio.

Mrs. Rothman stated she was one of the Board Members that originally voted to bring this program here. She stated that particularly today MAP is an important program. She has a good feeling about this program.

Mr. Bettan expressed his view that time helps a lot. The time is right.

Mr. Cepeda hopes that it is not too late. If this is not the right vehicle, what is.

Mrs. Pierno asked about the change in time between the schools. Mattlin will now have MAP at 8:00 a.m.

Mr. Mittleman has received positive feedback from the staff regarding the start of MAP at 8:00 a.m.

Ms. Gierasch commended the members of the Committee for all their work.

3. Staffing

Mr. Jonas reviewed staffing for the coming year. He reviewed modifications. He discussed retirements and changes in enrollment. He recommended an additional special education teacher for the 4th grade at Stratford Road. He recommended an additional .2 to run a particular art class. He recommended an increase in social studies at the high school of .4. He recommended that we assign an additional .1 teacher in technology and an additional .2 gifted and talented teacher. Mr. Jonas discussed the decrease in the Kindergarten enrollment. If the Board accepts all the recommendations, it will result in an increase of 0.9 teachers with an overall reduction of 5.8 positions for 2010-2011.

Mr. Jonas spoke of projected class size.

Discussion:

Mr. Cepeda noted that we are running a social studies class with eleven students. Will we run it if there are only five or six students. There has to be a point where we say it can't work.

Mrs. Bernstein stated that whenever we run a new class, we have to give it more time to see if it takes off. She would like to go forward.

Mrs. Lieberman was glad about the addition in art. She asked that administration watch the alternative ed class. They are our most at risk kids.

Mr. Jonas stated we would not desert these kids.

Mrs. Pierno agrees with the humanities block. We may not have gotten enrollment because they are honor classes. We can offer both and see how it runs.

Mrs. Lieberman stated that she would have thought that the kids would like a course like web design. She would have thought it would be a "hot" course.

Mrs. Bernstein asked that the Board be kept informed regarding staffing and class size.

4. <u>College Visitations</u>

Ms. Gierasch reviewed the college visitations program that Oyster Bay offers to tenth graders. The school district takes 75 sophomores to about 11 colleges and universities during a five-day period. They go to Goucher College, University of Maryland, College of William and Mary, North Carolina State University, University of North Carolina at Chapel Hill, Duke University, High Point University, Lynchburg College, University of Virginia, Georgetown University and American University. It would be a terrific opportunity for the students. The trip is fully paid by the students including the expenses of the chaperones. The cost is the students' responsibility. There is no cost to the district. She spoke of our current policy regarding field trips.

Discussion:

Mrs. Rothman stated if the classroom teachers go on the trip, there is a substitute teacher cost. She asked how the colleges were chosen.

Mr. Cepeda is concerned about taking the parent out of the selection process. He did note, however, if the child picks a particular school, the parent will still have to visit. He is a little hesitant about this.

Mrs. Bernstein stated that this does not take the place of the parent/child visit. Most parents don't take kids to visit colleges in the sophomore year. She stated that she likes the list of schools. They are all different types of schools. Students get a feel for what they want.

Mrs. Lieberman stated that the kids might eliminate schools by a visitation such as this.

Mr. Cepeda asked if we have a plan.

Mr. Dempsey asked if the Board wants to change the practice of not having overnight trips. This will open the door to other trips.

Ms. Aloe stated there are Commissioner's decisions on field trips. When you revisit the overnight field trip policy, she stated that you have to review the Commissioner's decisions. There are many issues.

Mr. Jonas expressed his views that sending kids to visit college is educational.

Mrs. Pierno stated that this works in Oyster Bay because they are very active in fund raising. She doesn't want to make this a trial. There are wonderful trips and we should look at this trip as well.

Mrs. Bernstein would like to see the cost of some of these trips.

Mr. Bettan stated that we have to ask Central to look into this and to allow a trip such as this to take place.

Mr. Jonas stated that we did not budget for any of these trips.

Ms. Gierasch stated there is not a lot of cost to the district with a trip such as this.

Mr. Dempsey stated we have a commitment for competitions. He will provide the Board with information as to what we have spent. It would not be a fund raising commitment. We have to consider all the implications including legal implications.

Mr. Bettan stated we have to have a proposal.

Mr. Cepeda stated we have to have a template to say what these trips fall under and how do we address specific issues.

Public Participation

Linda Jakobs, President of SEPTA spoke about the Oyster Bay Program. She informed the Board that on Monday, SEPTA had their track and field day. She stated it was very moving to watch the student athletes interact with the student with disabilities. The event was warm and compassionate. Mrs. Jakobs stated that some things you teach by words and some things you teach by showing.

Ms. Sophia Petchiony discussed staffing in the second grade in Pasadena School. She asked that we keep four second grade classes in Pasadena.

Meredith Lewin asked to meet with the Board to discuss the parking problems at the Fern Place School.

Mr. Dempsey stated that the property belongs to the Town of Oyster Bay. There has been one meeting with Town of Oyster Bay officials.

Mrs. Lewin asked to be kept in the Loop.

Mrs. Laura Rosenthal discussed the traffic problems on Orchard Street. Residents have called the police. She too wants to be kept in the loop.

Mrs. Cheryl Dender asked questions on the proposed report card. She asked if there is an area on the report card to indicate "effort". She expressed her views that two half days in a row can be a hardship for parents. Mrs. Dender thinks the high school trip visiting colleges sounds wonderful.

Mrs. Stefanie Nelkens discussed a letter she received regarding a summer reading program for her son. Her son never learned these things in school.

Mrs. Margo Garcia asked for a clarification of the trips. It was her understanding that we stopped sending kids on trips because parents couldn't afford them.

Mr. Dempsey stated that parental costs was part of the problem.

Mr. Jon Mosenson, President of High School PTA congratulated Mrs. Lieberman and Mrs. Bernstein on being reelected to the Board of Education. He thanked the Board for adding sections back. He spoke of an art event that he attended at which our students did very well. Mr. Mosenson asked what is being done with alternate education. He also stated that the cost of the educational portion of the trip has to be paid by the District.

Mr. Mosenson stated that the hour is very late now. He asked the Board to consider working meetings.

Mr. Ed Lesser discussed class size in the second grade at Pasadena. He believes 25 kids in a class is too high.

Mr. Jonas stated that the District watches these situations very closely.

Mr. Bettan also stated that this will be watched very closely.

A resident stated that evening conferences or early morning parent conferences would be more agreeable to most parents.

Mrs. Zoe Freeman discussed grading in the middle school. She spoke of remedial programs. She stated she is a stay at home mom with four children. She discussed conferences. Two half day conferences in a row is not productive.

Mrs. Jane Pace discussed MAP. She stated it should be made consistent and structured. She discussed bullying and she spoke of class trips. She stated that her daughter's trip to Quebec changed her daughter's life.

Mr. Morty Rosenfeld, President of the PCT is concerned about the discussions of parent teacher conferences that have occurred tonight. He stated it is a collective bargaining process that can't be changed outside the collective bargain process. He discussed MAP.

Physical Education Grading

Mr. Dempsey stated that next year we are keeping "pass/fail" in physical education. We will use a rubric to determine the pass/fail grade. We may go to a numeric rubric the following year. He stated the rubric is not ready now. Before the end of the school year, it will be shared with the Board

Budget Presentation

Mr. Dempsey stated that the economy affects the school district throughout the years. There were extensive increases in pension costs and health care costs.

Mr. Ruf gave an overview of the budget. He too discussed external forces impacting our District such as reductions in state aid and mandated increases and new costs. He spoke of the MTA tax, sewer usage fee and the potential tax cap.

Mr. Ruf reviewed state aid from 2008 through 2011. He reviewed internal strategies such as multi-year planning, the use of district reserves, cost saving projects, cooperative purchasing agreements as well as strong fiscal controls.

Mr. Ruf reviewed our budget history since 2008. The 2011/2012 budget is \$134,193,688. This represents a 2.52% increase from the 2010-2011 school year. The average tax increase on Long Island is 3.96%. He reviewed the tax levy. Mr. Ruf reviewed a contingency budget. He also discussed Proposition II, which authorizes the expenditure from the Capital Reserve Fund. He reviewed the projects to be done.

Mr. Ruf stated that if anyone had any questions, they could call him and he would be happy to answer them.

Public Participation

Mrs. Kathy Rea updated the Board of PTA events in the District. Old Bethpage finished their book fair. They are holding a plant sale this week. There will be a Parents Night Out at the Woodbury Country Club. Their book club is still running. She spoke of the Empty Bowl Night and how PTA helped get supplies and solicit food. Everyone had a wonderful time. She noted that the Kindergarten Center PTA is purchasing Anti-Bully Club wrist bands for their students. The students will be asked to say they will be kind to their fellow classmates. The Kindergarten Center joined forces with Stratford Road and held a successful coin drive for Japan Relief. The second graders at Pasadena Elementary School raised \$4,017.95 for St. Jude's Children's Hospital. POB Middle School PTA assisted on a trip to Finance Park for the 8th graders.

Ms. Jane Pace discussed our wellness policy and the cost of prom tickets. She spoke of how wonderful the high school show was. She spoke of how much sodium is allowable in one's diet. Items sold at the show contained too much salt. She asked the Board to reconsider the wellness policy.

Mr. Richard Siegelman spoke of tenure for males versus females. He spoke of physical education grading. He hopes the physical education grade goes in the transcript and that it be given equal weight with other subjects. Mr. Siegelman expressed his views that the bullying policy is weak. He also reiterated his views that if we charge some students \$10.00 for field trips all students should be charged.

Ms. Maureen Kenney, a teacher at the Kindergarten Center spoke on behalf of the two teachers losing their positions. The loss of these teachers is a tremendous loss. She asked the Board to reconsider.

Ms. Susan Naftol, President of MAPOB spoke of the event they sponsored. Third graders were being advised by high school students. It was a wonderful event. She thanked Mrs. Amy Pierno for attending. She also thanked Josh Golbert, Director of the Music Department for his help.

Ms. Stefanie Nelkens spoke on behalf of retaining the speech teachers. She discussed a movie, Race to Nowhere, a documentary. She stated she feels the district should have a discussion about testing. She doesn't understand why her son is subject to additional testing the same week as ELA testing. She doesn't know why our district wants to participate in the high school social studies test. She wants to give the kids a break. She stated the testing situation is awful.

Mr. Dempsey stated there is a chance students can be excessively pressured. We are trying to achieve a balance. The social studies test is a useful test.

Unfinished Business

Anti-Bullying Policy and Regulations

Mr. Dempsey stated that changes have been made to the anti-bulling policy.

Mr. Jonas stated that Administration has met with the DASA Committee and they reviewed the policy.

Anti-Bulling Policy and Regulations (continued)

Discussion:

Mrs. Lieberman stated she wants a policy that will work. She doesn't want one that is so broad that everything is going to be considered bullying. You have to be able to understand that some behavior that is in the policy is not bullying. She expressed her views that this policy is unrealistic. Poking is not bullying. It could be kids just fooling around.

Mr. Lieberman discussed graffiti. The word "graffiti" is too general. She wants it to be more specific. She stated that verbal teasing is not bullying. She wants to state what constitutes bullying and how we can control it.

Mr. Jonas stated that language in the policy states, "it may include but not be limited to..." An investigation would go on.

Mrs. Lieberman stated the scope of this policy is too broad. She doesn't feel it can succeed if you make it wider and wider. The policy has to work.

Mr. Cepeda stated it is subjective.

Ms. Aloe stated it includes language from DASA.

Mr. Cepeda stated you have to give administrators the opportunity to review.

Mr. Bettan asked where the word, "graffiti" came from.

Mr. Jonas stated the DASA committee wanted it.

Mrs. Bernstein stated that she believes the intent of the policy is that graffiti would increase a hostile environment.

Mr. Dempsey stated that we get input from the Committee but the Board is the final arbitrator. He too spoke of the wording, "including but not limited to".

Mr. Jonas stated poking has the possibility to be bullying.

Mrs. Pierno stated that the words in graffiti could be a form of harassment.

Mrs. Lieberman stated that using words such as, "a prank was done to my child" could be considered bullying. We are going to be inundated with a lot of complaints. She described what bullying is. One time incidents don't constitute bullying. Incidents that are on-going are considered bullying.

Mrs. Schulman expressed her views that there is going to be an issue of interpretation. Bullying does not have to be intentional. The crux is does it meet the standard of harming someone.

Mrs. Lieberman described bullying.

Mrs. Pierno asked what the effect is on the student.

Mrs. Lieberman stated in reality a lot of what is in this policy goes on every day. She wants a policy that we can implement and have results from.

Mr. Cepeda expressed his views that we are getting caught up in words.

Mr. Jonas stated that all policies that have consequences require administrators to review.

Mr. Guercio stated that when you go beyond what is mandated in the statute you have problems. He read from the statute. He stated that when you rewrite legislation, stick with the language from the statute.

Mrs. Rothman stated that a lot of this policy is subjective.

Mrs. Lieberman reiterated that the policy is too broad.

Mrs. Rothman suggested we keep it simple.

Mr. Bettan stated we want to educate kids not to bully. We want to detect something early and nip it in the bud. He stated that you can't satisfy everyone.

Mr. Guercio stated that the statute includes wording, "including, but not limited to".

Mr. Guercio stated that the policy should be re-circulated and the attorney will write a concise policy.

Mrs. Pierno discussed an article Mr. Dempsey shared with the Board.

Mr. Guercio stated that the intent of the statute is to give you flexibility.

Mr. Dempsey spoke of training that we provide to the staff and kids but is not in the policy.

Mrs. Schulman asked if the staff is obligated to report bullying. She asked if the wording we have is strong enough.

Mrs. Schulman stated that she wants consistency in all buildings.

Mr. Guercio stated that part of what is odd comes from the statute that singles out conduct that is in our Code of Conduct policy. These are not new issues. This antibullying policy should be consistent with our Code of Conduct policy.

Mrs. Lieberman stated that it is through staff development and consistency of programs. These programs should start in the Kindergarten Center and they should be built on from there. We also have to get parents involved.

Mr. Guercio stated the rules already exist. Changing the culture is not going to happen with a piece of paper.

Mrs. Schulman expressed her views that we should draw attention to this issue.

Mr. Jonas stated we are going to circulate the policy.

Mrs. Bernstein discussed training prevention. It doesn't say we want our staff to be trained to identify it when it is going on.

Mrs. Bernstein asked if the word "empathy" can be added under No. 4. Under Regulations, page 5, last paragraph, she would like the words, "parent or legal guardian" added.

Mr. Bettan discussed cyber-bullying. He asked about case law. It doesn't necessarily happen in the classroom.

Ms. Aloe responded that there needs to be a nexus in the school. There needs to be some connection to the school.

Mrs. Lieberman asked why video gaming devices was added.

Mr. Jonas stated there is a nexus.

Mrs. Lieberman stated we have to stress and educate the importance of confidentiality. Children's names should not be used.
