Dr. Lewis said that some of the technology students created an IPHONE charger.

Mrs. Lieberman asked that at the next Board meeting, there is more information that can be shared in regards to the usage of the 3D printers.

Mrs. Bernstein stated the she is in favor of the overnight trips. She feels that they need to have a future discussion on the trips and how it should be equal within the grades.

Mrs. Lieberman said that they are just beginning and feels that this is foundation money.

Mrs. Pierno asked how many trips will this cover, and also what about the transportation and substitute costs.

Mr. Ruf explained about the trips that were proposed.

Mrs. Lieberman stated that maybe they should hold this change.

Mr. Bettan said that he feels they should go ahead with it so that there is some money in the code and they can move forward.

Dr. Lewis stated the number represents the amount of the three proposed trips. She asked the Board how she should proceed.

Mrs. Rothman feels that these trips should be approved and asked Dr. Lewis to get the Board information on the Middle School's future trips.

Mrs. Lieberman asked for clarification at the next Board meeting on how many more units of chaperones will be needed for future trips.

Discussion:

Mrs. Pierno stated that she wasn't sure why they are doing this now. She stated that, at the Leadership Summit, there was a discussion and a lot of ideas were discussed. She feels that this may not be the best solution.

Dr. Lewis stated that students with IEP's struggle to fulfill the health instruction. She also stated that instruction must be with a certified health teacher. She feels that it would be a beginning.

Mrs. Schulman asked what grades we are talking about.

Dr. Lewis said 6th & 8th.

Mrs. Bernstein stated that at least the money would be there for whatever is decided.

Mrs. Schulman spoke about the concerns she has for children also missing art and music, those of which are important to them. She feels that having the money in the code is a good idea although she does have some concerns.

Mr. Bettan thought that this was a creative approach to chip away at the problem.

Mrs. Rothman stated that when students are getting to High School they are at a disadvantage, because there are so many important issues in regards to health. She feels that this is something we need to support.

Mrs. Lieberman stated that this is a beginning.

Resolved upon motion by Mr. Bettan, seconded by Mrs. Bernstein that the Board of Education approve the following recommended change to the 2014/2015 Plainview-Old Bethpage budget:

Mr. Bettan feels that it is an ambitious project, and that maybe we should start with one grade.

Dr. Lewis said that she will reach out to the Administrators and come up with a plan.

Mrs. Pierno stated that she supports the Elementary Extra help, but she feels like they are rushing in. She spoke about the students not being comfortable with a teacher that's not their own, and in speaking with the Administrator's she feels that it will be tough getting the staff to commit. She stated that she would like it done the right way.

Mr. Rosenfeld stated that Mrs. Pierno doesn't offer a fair overview. He said that the topic has been heavily discussed for over a year.

Mrs. Pierno feels that it is not something the Board has had discussions about.

Mrs. Rothman supports this program. She feels that with all the challenges in regard to the Common Core, she feels that the students will come because of the challenges they are facing. She stated that perhaps down the line it may reduce AIS and remedial costs.

Mrs. Schulman expressed her concerns about the students coming, especially that it is going to be offered before school.

Mrs. Bernstein agrees and feels that they should start with a pilot program.

Mrs. Lieberman stated that if the money is there, then a plan can be put in place for September.

Resolved upon motion by Mr. Bettan, seconded by Mrs. Rothman that the Board of Education approve the following recommended change to the 2014/2015 Plainview-Old Bethpage budget:

Discussion:

Mr. Bettan asked about the costs related to the security booth and tennis courts. He also asked if they can add more money to the code.

Mr. Ruf stated that it would be a six figure cost for each, the tennis courts and the guard booth.

Mrs. Lieberman spoke of a bond possibility and that the work that's done in this code must be done quickly.

Mr. Bettan stated that the Board should pick a number they are comfortable with and not name the projects, and that it can always be tweaked later.

Proposition 1: Budget

Mr. Ruf gave an overview on the budget draft.

Discussion:

Mrs. Bernstein asked if we will know what our State Aid is.

Dr. Lewis stated that we should know tomorrow and they are projecting \$200,000.

Proposition 2: Authorization to Expend from 2010-2011 Capital Reserve Fund

Mr. Ruf spoke about the Capital Reserve Fund. The Capital Reserve Fund was authorized by voters in the May 2010 not to exceed \$5,000,000. Mr. Ruf spoke of using the remaining \$442,312 left in the reserve to support the Mattlin MS skylight and related roof work replacement project.

Proposition 3: Establishment of Capital Reserve Fund

Mr. Ruf spoke about the Capital Reserve Fund and how the fund is an account proposed by the Board set up for the financing of future building renovations, improvements and infrastructure needs. Mr. Ruf spoke of how the Capital Reserve Fund gets established, terms purpose and funding sources. He went on to mention the benefits associated with establishing the Capital Reserve Fund.

Public Session

Ms. Cheryl Dender thanked the Board for addressing a lot of the PTA's questions. She was happy to hear progress being made in regard to starting a pilot program for Elementary extra help. She spoke of the importance of the overnight trips. She questioned line 27 in the budget modifications and asked why they are reducing the Asst. PPS director position, she added how important health was and stated how happy she is to see it addressed.

Dr. Lewis explained line 27 and stated that line was being held.

Ms. Andrea Goldman asked about the 1.0 FTE in the high school.

Dr. Lewis stated that it addresses the issue with the Dean position.

Ms. Paula Barskey spoke of the leadership summit and the Middle school extra day of remedial. She also spoke of the Special Education students having to miss health and other programs that they really enjoy.

Dr. Lewis stated that no set plans have been made and that it was still being discussed
