Mr. Bettan called the meeting to order at 7:55 p.m. and welcomed everyone to tonight's Board of Education meeting.

The Pledge of Allegiance was recited.

Mr. Bettan noted that a few items on the agenda will be taken out of order this evening.

#### School Board Recognition

Mr. Bettan stated that Governor Paterson has declared the week of October 25 through October 29 as School Board Recognition Week. Mr. Bettan recognized former Board of Education members in the audience and thanked them for all their work on behalf of the students of Plainview-Old Bethpage.

Councilwoman Rebecca Alesia, representing Supervisor Vendetto and the other members of the Town of Oyster Bay Board presented the Board of Education with a Proclamation and thanked the Board Members for all they do. She stated her daughter will be starting Kindergarten next year and she looks forward to that.

#### High School Update

, our high school representative updated the Board on events at the high school. She noted that Home Coming was wonderful. She thanked Board Members for attending. It was a great day.

## School Board Recognition (continued)

Marilyn Sacks representing the Senior Citizen Club thanked the Board for all they do and presented each member with a gift. Jerry Kirschen, also a member of the club, thanked the Board for all they do on behalf of the Seniors in the District. He noted that not many school districts do for senior citizens the things that Plainview does.

Cathy Shapp, President of PTA Council and other members of PTA sang a song to the Board and presented them with a gift. Mrs. Shapp thanked the Board for everything they do all the time for the children and residents of the community.

## **Board of Education Announcements**

Mrs. Pierno stated that she, Mr. Cepeda and Mrs. Schulman attended Home Coming. It meant a lot to the boys playing football to have everyone out cheering for them. She stated that she will be attending more athletic events and urged everyone to come out and cheer our students on.

Mr. Cepeda stated that he attended the DECA fashion show at the High School. It was a wonderful evening. He expressed his views that our kids have a tremendous amount of talent.

#### Superintendents Announcements

Mr. Dempsey stated that at the November 22 we will be having student recognition night and we will be honoring the achievements of our students.

Mr. Dempsey stated that this morning he attended a legislative meeting regarding the issue of tax certiorari.

Mr. Ruf stated that he, Mr. Cepeda and Mrs. Pierno also attended this legislative meeting. He explained that Nassau County wants to shift the burden onto school districts, libraries and fire districts. The current County Legislature is debating whether to change the Charter. Mr. Ruf stated that if the shift occurred, each school district would incur an approximate 1.4 million dollar expense. Mr. Ruf stated we will continue to request the County not shift the financial burden onto schools.

Mr. Dempsey stated that we have strong concerns regarding this tax certiorari issue and have voiced these concerns.

Mr. Dempsey stated there will be a Marching Band Festival on October 19<sup>th</sup> at Hofstra University. Our band will be participating. Mr. Dempsey stated it is always a great event.

November 2<sup>nd</sup> is Superintendent's Conference Day. Most of the day will be devoted to school climate. Everyone will meet at Plainview-Old Bethpage Middle School to hear Charlie Abourjilie. He will give a presentation to the entire district in the morning. In the afternoon he will do smaller presentations in the individual schools.

Ms. Gierasch was pleased to inform the Board of "Good Happenings" throughout the district. Pasadena won the Public Library Summer Reading trophy for the 2<sup>nd</sup> year in a row. We are going to create an interdisciplinary project for math and science students to submit for a math fair. A SIMS trainer worked with our Special Education teachers. Jennifer Santorello was recognized as the New York Business Teacher of the Year. Brian, O'Sullivan, Chairman of LOTE, Dorothy Kleinman and Linda Stack will be going to the National LOTE Conference in November. At POB Middle School the MAP Leadership Pilot is off to a good start. Meryl Menashe is being recognized next month by the Nassau Holocaust and Tolerance Center.

Mr. Dempsey stated that October is National Anti-Bullying Month. He shared some of the anti-bullying programs that are going on this month in all our buildings.

## External Audit Report – 2009/2010

Marianne VanDuyne of R.S. Abrams & Co, our external auditor, stated that the Plainview-Old Bethpage School District received an unqualified opinion which is the best a district can receive.

Ms. VanDuyne stated that she met with the Audit Committee and reviewed the Audit Report. She thanked the members of the Audit Committee. She was very impressed with the knowledge and expertise exhibited by the members. The management letter suggested a few improvements. She stated that the school district is doing an excellent job. She noted that the Business Office has implemented recommendations from previous years. She stated that the Plainview-Old Bethpage School District was financially better prepared than other school districts she has audited

Ms. VanDuyne stated that this year the District put some money into reserves and gave money back to the taxpayers. The District is moving in the right direction. We have a strong balance sheet. She discussed GABS 54.

She thanked Mr. Ruf and his staff for the fine job they are doing.

Mr. Wolfson, Chairman of the Audit Committee expressed his views that everything is very open and above board. There is transparency for all members of the community. Mr. Jack Tolbin, a new member of the Audit Committee stated he is impressed with the quality of the Board and the openness that is exhibited.

Mr. Cepeda thanked Ms. VanDuyne for her comments. He thanked the community members who give their time.

Mr. Bettan thanked Mr. Ruf and all the members of the Business Office for all their work. They do a great job.

#### Goals

Mr. Dempsey reviewed the goals that were discussed at previous meetings. He noted if the community has any comments they can send them to him and he will share them with the Board. He discussed the State's standards. He reviewed school climate. Mr. Dempsey stated that we are looking to choose a school climate survey. He spoke of the Dignity for All Student Act. He reviewed the district's financial goals. Mr. Dempsey

noted that if the County makes changes in the way tax certiorari done, it won't happen until 2013.

Mr. Dempsey stated wording will be incorporated into bullet number 4.

Mrs. Rothman asked if we will get BOCES aid if we use one of their surveys.

Mrs. Pierno asked if the survey will include academic standards.

Mr. Dempsey stated it would. The issue is about student engagement.

Mr. Bettan asked how soon we will be able to get the Dignity for All Student Law into effect.

Mr. Cepeda asked if we are going to have wording that will support technology in order to improve academic standards.

Mrs. Lieberman stated that technology is part of an on going goal.

Mrs. Pierno asked if we are continuing with our initiatives from last year.

Mr. Dempsey stated it is not possible to continue all the goals from last year as well as these new ones.

Mrs. Bernstein discussed the writing goal.

#### **Public Participation**

Mr. Sully Goldberg congratulated the Board on School Board Recognition Week. He informed the Board that he and other veterans will be receiving a medal for having served at Normandy during WWII. He spoke of the way in which goals are decided.

Mr. Jake Gilman spoke in his capacity as High School Executive Board President. He reviewed things that are not allowed now in school because of "liability". Speaking on behalf of the students, he stated that the scavenger hunt should be allowed. He stated that parents should be the ones that stop their children from participating, not the school district. He spoke of field trips that students do not go on now. He discussed fund raising and how the new the Wellness Policy impacts on the students' ability to raise money for events and clubs.

Mr. Dempsey responded.

County Legislator, Judy Jacobs, presented the Board with individual citations and commended them for all the wonderful work they do. She also presented members of the Board with gifts that stated that "Teamwork is the ability to work together toward a common vision". She stated that the Board has this vision.

#### <u>Public Participation</u> (continued)

Linda Jakobs, President of SEPTA spoke of an integrated co-teaching class at the high school. There were ten students in the class. She and SEPTA are very concerned about this situation.

Mr. Dempsey stated there is one class where the number is higher than last year. We are watching it very closely.

Mr. Jon Mosenson, President of the High School PTA, stated that the number in the collaborative classes was supposed to 7. He spoke of a previous Board Meeting a few years ago when he was on the Board. He doesn't think the intention was ever to go to ten students. When there are that many students in a co-teaching class, both the special ed students and the regular ed students lose out.

Mr. Dempsey reiterated that we are looking at this situation very closely.

Ms. Jane Pace expressed her views that she is proud to be a parent of a high school student in the Plainview-Old Bethpage School District. She spoke of the students' fund raising efforts and what they fund raise for. She spoke of how difficult it is for them now to raise necessary funds. In the past, bake sales raised a lot of money. She stated it is very hard to raise money now because of the restrictions in the new Wellness Policy.

Gan Yao discussed class size. She spoke of last year's math tests. Our scores compared very well to other districts.

Mr. Jacques Wolfner discussed the tax certiorari resolution. He also discussed the sewer tax. He stated there are two sides to every issue. He asked for a detailed explanation of several items under, "Finance".

Mr. Guercio stated there are not two sides to the issue of tax certiorari. The County of Nassau makes the mistakes. It is common sense that the agency that makes the mistake should pay for those mistakes.

Mr. Sean Cobitz, Vice President of DECA as well a member of other school clubs discussed bake sales and other fund raising efforts.

There were approximately 30 district residents and staff members present.

Mr. Bettan called the meeting to order at 7:45 p.m. and welcomed everyone to tonight's Board of Education meeting.

The Pledge of Allegiance was recited.

## High School Representative Report

, our high school representative updated the Board on events at the high school.

#### **Board of Education Announcements**

Mr. Bettan thanked everyone who attended the Board's workshop on Monday, September 27. He stated it was an informative meeting that gave the community an opportunity to see how the Board formulates its goals. He stated that the Board will be continuing to discuss the goals and narrow down the list. Mr. Bettan stated that the Board looks forward to the community's comments during public participation. We will be integrating those thoughts and comments into the final document.

Mr. Bettan noted that we will be receiving a report on the Science results for grades 4 and 8. We will also be receiving a report on the results of our 8<sup>th</sup> grade Social Studies. We will then be hearing about the new elementary science and social studies curricula.

Mr. Bettan stated that Mr. Dempsey will report on the District's Emergency Response Plan and give an update of the natural disasters that occurred in the District last week.

Mrs. Rothman stated that last week she, Mrs. Bernstein, Mrs. Pierno, Mrs. Lieberman and Mr. Jonas attended a seminar on Essential Policy Elements of School Safety. They obtained very important information on school climate. They received sample policies that conform to the Dignity for All Act.

Mr. Jonas noted that the next day, because of flooding on the streets surrounding the Old Bethpage School, we implemented our Emergency Response Plan.

Mr. Cepeda stated that last week, he and Mrs. Pierno attended the Nassau-Suffolk School Boards Association Resolutions Dinner. An item of particular concern that was addressed at the meeting was the issue of a tax cap. He stated the speakers gave reasons why the tax cap was no good and ill advised. All the speakers asked that we call our elected officials. He noted however, there is a growing sentiment for a tax cap. There is heavy lobbying for this. He believes the arguments against a tax cap are correct. However he expressed his views that we need to control costs and still meet the education expectations of our community. We need to be prepared—either way this issue goes.

Mr. Bettan stated that we are fortunate to have an expert on bullying on the Board—Mrs. Lieberman. He stated she was on Fox News, MSNBC and other news outlets over the weekend addressing the subject of bullying and cyber bulling.

Mrs. Lieberman discussed the level of meanness that occurs daily. She noted that suicide is the number three killer of our children. She stressed that we must talk to our children. We have to teach tolerance and diversity. We have to teach niceness. She urged that we start this education at a younger age.

Mrs. Bernstein asked if we are using the Rutgers tragedy, where appropriate, in the District as a teaching moment.

Mr. Dempsey stated he will be talking with administrators tomorrow about this.

Mrs. Bernstein would like to hear what plans we have at a future meeting.

Mrs. Lieberman stated that we should start in the middle school.

Mrs. Schulman asked if homophobia is being addressed. She noted that teen suicide rates are higher among gay and transgender children.

Mrs. Dempsey is very impressed with our high school students. Homophobia is being addressed at the high school. He is not sure it is being addressed at the middle schools.

Mr. Bettan stated the Board and Central Administration toured the buildings. He complimented the Building and Grounds team on the great job they did. Our grounds and schools look wonderful. We are doing more with less. Building and Grounds personnel completed many projects in house and saved the District money. He thanked them for all they are accomplishing.

#### Superintendent's Announcements

Mr. Dempsey discussed the power outage at Mattlin Middle School. Our response was great. The students adjusted wonderfully as did our staff. He noted that Principal Mittleman and the staff at Mattlin, Head Custodian Joe Cammareri and his staff and Ms. Parahus, Director of Facilities did an outstanding job. LIPA analyzed the issue. An outside electrical firm that we used in the past was hired and Parent Link was used.

Mr. Dempsey also noted that a district server failed. He thanked Mr. Lodico for all his work.

On Friday, there was a flooding problem on Round Swamp Road. It was necessary to redirect the school busses from Old Bethpage Elementary School to Mattlin Middle School. The staff at Old Bethpage did a great job as did the Mattlin staff. Students were relocated temporarily. Mr. Dempsey thanked everyone again.

Mr. Dempsey stated that our school did not receive any Race to the Top money. He explained why this happened.

Mr. Cepeda noted that even if we had received some money, it would have been a minimal amount.

#### Audit Committee Member Recognition

Mr. Ruf explained the need for and the reasons why an Audit Committee was established. He spoke of the dedication of Mr. Gerry Ring, the former Audit Committee Chairperson. Mr. Bettan presented Mr. Ring with a plaque. He stated that Mr. Ring set the bar very high for those who follow him.

#### Reports

#### Science Report – Grades 4 and 8

Ms. Gierasch applauded Mrs. Barry and the teachers involved in the project.

Ms. Barry discussed the 4<sup>th</sup> grade assessment results. The percentage of students who passed remains steady. We did increase in level 4. She discussed the 8<sup>th</sup> grade results. In ILS we had a 5% increase of students in level 4. There is quite a bit of writing going on. Ms. Barry reviewed the Earth Science results. 100% passed. 83.8% achieved mastery. She complimented the high school and middle school teachers.

Ms. Barry discussed and reviewed the pacing charts. She spoke of how this is integrated into the regular curriculum. It is a working tool for the classroom teacher. It is constantly changing and improving. She discussed the integration of Enrichment for All into the program.

#### Social Studies Report - Grade 8

Ms. Maria Carnesi celebrated the success of the staff and the kids. She discussed the 5<sup>th</sup> and 8<sup>th</sup> grade exams. She noted there was a shift in the movement from level 4 to level 3. She spoke to that point. She explained how the marks were determined. Teachers are very skilled at accurately assessing the quality of the students' work. 93.7% of the 8<sup>th</sup> grade passed. 14% increased in mastery over one year. Teachers have been doing a wonderful job. She discussed the elimination of state assessments in grads 5 and 8.

Mr. Dempsey stated the State eliminated these tests as a cost saving feature. The State may revisit this.

Ms. Carnesi discussed the curriculum for grades 3 and 4. She thanked the teachers she worked with over the summer. They did an outstanding job.

Ms. Gierasch noted that technology was included.

#### Discussion:

Mrs. Bernstein thanked Ms. Barry and Ms. Carnesi for their reports.

Mrs. Lieberman was pleased to see articulation between the grade levels.

Mrs. Rothman was impressed with the framework of the curriculum.

Mr. Bettan stated he is very proud of our district. We are integrating our curricula. The staff is doing a great job.

#### Board Goals Update

Mr. Dempsey reviewed the three areas that were decided upon on at last week's workshop on goals: Academic Standards, School Climate and Finances.

He read the preliminary wording of the academic goal.

#### Discussion:

Mrs. Rothman stated she would like to see a framework in order to implement districtwide assessments.

Mrs. Pierno asked if we could look at outside sources. She stated that she doesn't know what these sources would cost.

Mrs. Rothman asked if the science and social studies that were presented to the Board tonight was done elsewhere.

Ms. Gierasch stated that we asked what students need to learn at this level.

Mr. Dempsey stated that we should look at the outcomes we want to establish.

Mr. Dempsey stated the PCT made recommendations on core knowledge. We should incorporate some core knowledge that is all the same in all buildings. Perhaps our academic committee could look at this.

Mrs. Pierno stated that last year we had writing as a Board goal. Perhaps writing still should be incorporated in our goals.

Mr. Dempsey noted that last year's goals were multi-year.

Mrs. Lieberman stated if something is an on going goal, it is understood. We should try to keep the goals where they are.

Ms. Gierasch stated the writing goal will continue.

Mrs. Schulman asked if we are referring to the accelerated number of subjects.

Mr. Dempsey stated we will be looking at more students or more subjects.

Mrs. Schulman stated she is interested in acceleration in all grades.

Mr. Cepeda discussed advanced placement.

Mrs. Pierno stated that she hopes part of the plan is that we let kids have opportunities to accelerate.

Mr. Dempsey discussed the Academic Standards Committee.

#### School Climate.

Mr. Dempsey explained that we want to provide a school climate in all our buildings where all members are welcomed, supported and feel safe. He reviewed how we will do this. He would like to select and conduct a school climate survey by Thanksgiving and have the results back before January. He would like to create an anti-bullying policy prior to the beginning of the 2011/2012 school year.

#### Discussion:

Mr. Cepeda would like to move the time frame up and have a policy sooner.

Mrs. Rothman noted that NYSSBA has provided sample policies from which we could pick and choose.

Mr. Jonas stated it would have to be customized for our district.

Mrs. Lieberman stated policy is important. It would be the starting point. She also doesn't want to wait until next year.

Mrs. Pierno asked if there is something we could do and look at to see what schools could be doing. There should be kindness, respect and civility.

Mrs. Schulman asked if there are previous school surveys that we could look at.

Mrs. Bernstein noted that at least ten years ago, we conducted a bullying survey. Perhaps we could look at that.

Ms. Gierasch stated that the middle school put together a survey. We will have that data shortly.

Mrs. Rothman asked how are we going to evaluate each survey we will use.

Mr. Dempsey stated there are many instruments that are used.

Mr. Bettan stated that school climate is a change in the culture in our district. We have to work together to make it happen. He discussed cyber-bullying. We have to be prepared to model behavior and not just in school.

Mrs. Bernstein stated that a number of years ago we brought MAP into the district. A lot of what we discussed tonight was supposed to be addressed during MAP. She expressed her views that perhaps we should look at our MAP Program to see if it is working.

Ms. Gierasch stated that we will be revisiting the initial goals of MAP.

Mrs. Lieberman asked if we could get a "heads up" when a pilot is being instituted.

#### Finance

Mr. Dempsey discussed the possibility of a property tax cap. He expressed his views that we may be facing difficult times.

Mr. Guercio discussed tax certioraris. He stated that things are looking bleak. In the last round, he was able to thwart the County's effort. The new County Executive is proposing changing the Charter. He discussed what the school districts are up against this time. One thing is certain. The County Executive is not backing off.

Mrs. Pierno stated that three out of the four "bullets" under Finance are reactive. She would like a pro active goal.

Mr. Bettan suggested that perhaps we could set a limit of increasing our budget by 2%.

Mrs. Lieberman is uncomfortable with limiting ourselves to a 2% budget increase. We have not even started our budget deliberations. Perhaps we should look at how we spend out money. We don't know what is being cut.

Mr. Cepeda stated we could set a framework of where we want to be. He noted that 70% of our budget is labor costs.

Mrs. Lieberman stated we have to evaluate programs.

Mr. Cepeda stated that we have to be conscious of what our community can sustain.

Mrs. Bernstein agrees with Mrs. Lieberman. She is hesitant about putting a cap on our spending. She wants to look at everything we have. Perhaps some things could be delivered at less cost. She is reluctant to set a hard and fast number.

Mrs. Rothman is reluctant to say we will have only a 2% increase. We have not seen an itemized list.

Mr. Bettan noted that the 2% number he spoke of was based on what we have done in prior years.

## <u>Update on Enrollment</u>

Mr. Jonas stated that we have a net change in our enrollment. It has decreased by 100 students.

Mr. Bettan asked about census data. He noted that there are a lot of baby carriages in his neighborhood.

Mrs. Bernstein also has seen a tremendous amount of baby carriages on her block and in her neighborhood.

Mr. Bettan would like to look forward five years.

#### **Public Participation**

Ms. Randi Goldberg asked the Board to reconsider approving the proposed changes in the Wellness Policy. Her children are finding it hard to find healthy choices. Clubs are suffering in their fund raising efforts.

Mr. Mark Rosenthal discussed tenure. He is against grading teachers on the results of state tests. He discussed his previous retirement incentive suggestions.

Mr. Lessman, representing POB Parents Against Bullying thanked the Board of Education, Mr. Dempsey, Mr. Jonas, Mr. McDermott and the school principals who attended their meeting last week. He suggested a time line for a written policy on bullying. He also suggested the establishment of a committee on bullying. He noted his group will be having another meeting in a month.

Ms. Darlene Baker stated that a special education teacher only comes into her son's first grade class for  $2\frac{1}{2}$  hours a days. She feels a special education teacher should be in that class all day. There is not enough support.

Ms. Stefanie Nelkens discussed the social studies assessment. The fifth grade work that her son is learning now is all new to him. It is not review. It is all new material. She asked how the students will be prepared for the 5th and 8th grade exams. She asked if the proposed assessment would be part of the student's grade.

Ms. Tracy Gorman spoke of the bullying her children experienced. She asked that bullying be stopped now. We can't wait for the establishment of a policy.

Ms. Suzalla stated that her mother was not impressed with the number of books her child had to read over the summer. When Ms. Suzalla was a student in POB, she had to read many books over the summer. She discussed what she was told goes on during MAP. Ms. Suzalla expressed her views of what Administration is doing. She asked the Board to consider bullying in parts. Consequences should be established for children.
