POB CSD TI Graphing Calculator Borrowing Agreement

I, _____, agree to borrow a TI Graphing Calculator from the Plainview-Old Bethpage CSD until the completion of my math course given the following conditions:

- I accept full responsibility for the borrowed TI graphing calculator until it is returned upon the completion of my math course.
- If the borrowed TI graphing calculator is lost, stolen, or damaged during the time I am borrowing the calculator, I must replace the calculator with a new TI graphing calculator or pay a replacement fee of \$75.00. If I choose to replace the TI graphing calculator, it must be the same model as the TI graphing calculator that I borrowed and it must be a new TI graphing calculator in an unopened package. If I choose to pay the replacement fee, I will make the check payable to *Plainview-Old Bethpage Central School District* for \$75. If I replace the calculator under the stipulations mentioned above or pay the replacement fee, I will be issued another TI graphing calculator to borrow until the completion of my math course.
- Although the borrowed TI graphing calculator includes four functioning AAA batteries, I am responsible for replacing the batteries during the time I am borrowing the calculator.
- I understand that the calculator remains the property of the POBCSD, and, under no circumstances, unless directed by my teacher, am I permitted to download any programs and/or games to this device. If any unauthorized programs are found on my borrowed TI graphing calculator during the time that I am borrowing the calculator, I forfeit the opportunity of borrowing a TI graphing calculator from POBCSD in the future, and I acknowledge that the calculator will be confiscated. There will be no warnings in this matter.

Obtaining a TI Graphing Calculator to Borrow:

The student will be issued a TI graphing calculator to borrow AFTER all of the above information has been completed and submitted to the student's math teacher. Upon being issued a TI graphing calculator to borrow, the student will need to complete a *Calculator Identification Card* that will later serve as the student's receipt upon return of the TI graphing calculator.

Returning a borrowed TI Graphing Calculator:

Aside from students in Algebra and Geometry, the borrowed TI graphing calculator must be returned to the POB CSD upon the completion of the math course or on the day of the Regents exam AND must be in working condition and undamaged. **In order to be issued a receipt, the internal and external graphing calculators numbers must match those listed on the *Calculator Identification Card*.**

Students enrolled in Algebra and Geometry will return their TI graphing calculators upon the completion of the Algebra II Regents exam.

If the borrowed TI graphing calculator is not returned/replaced, a replacement fee is not submitted, **or the internal and external TI graphing calculator numbers do not match those listed on the *Calculator Identification Card***, your child will be affected in any number of ways including, but not limited to:

- Driver's Education eligibility
- Student Parking eligibility
- Student ID card
- Junior Gala eligibility
- Off-Campus privileges
- Senior Prom eligibility
- Graduation Tickets
