Mrs. Lieberman called the meeting to order at 8:05 p.m.

The Pledge of Allegiance was recited.

Board Announcements

Mrs. Lieberman wished Marcia Turletsky all the best in her upcoming retirement.

Mr. Bettan spoke of the Common Core seminar that he and the other Board members attended to review the reasons of the need for the Common Core, Bill Daggett and Tom Rogers were the speakers. He spoke of the very informative slides regarding the driving force on which this initiative is based upon. He said that what the slides indicate is not that the schools are failing, but that the standards of colleges have gone up. He feels that we need to get the focus back on learning and not just testing, and to figure out what skills we need our kids to have to be successful.

Mrs. Schulman spoke about how much good the kids get from performing in these shows. She said that the female role in "Anything Goes" was small and a few of the girls split the roll. She also stated that some of POB's alumni who are studying theater in college were also included in the show, and how wonderful it is for the students to see what career opportunities there are.

Mr. Greenberg mentioned that the Federal Government recognizes May 1^{st,} as "Law Day" and that the theme this year is "American Democracy, The Role of Law and Why Every Vote Matters". He suggested the possibility of incorporating it into the curriculum. On a side note he said, "it's important to have your voice heard: make sure you vote on the May 20th, School Budget.

Mrs. Pierno attended the National Art Honor Society Induction Ceremony and she congratulated the 24 new members. She said that at the

end of the ceremony she was fortunate enough to have the winning bids for two pieces of art work; one from Victoria Ring and one from Rachel Davidson. She also attended The Career Fair at Mattlin Middle School. for both Mattlin and POB students. She stated that the program was divided into two groups, the first being a career workshop and the second an assembly program. She congratulated Mrs. Epstein, the staff of both schools and all the local professionals. Mrs. Pierno also attended the same seminar as Mr. Bettan and she spoke of the afternoon session presented by Deer Park schools and their support of the Common Core. They have developed their own version of the curriculum which they feel has been very successful.

Mrs. Lieberman wanted the record to show that POB was within the guidelines for the Veterans Tax Exemption and in full support of it, and that Nassau County had changed the guidelines.

Mrs. Pierno attended "Anything Goes" and was thrilled to see five music students as part of the Orchestra pit; she hopes that if there is an interest, it will expand.

Superintendent's Announcements

Dr. Lewis wanted to recognize the Odyssey of the Mind team from POB Middle School for coming in second place over the weekend; they are off to lowa for the world champions. She also spoke about POBOTs, DECA and all of our wonderful programs.

Dr. Lewis spoke of the tree that was created in the High School, to which all of the seniors add a leaf with the name of the college they are attending. She wanted to thank the guidance counselors for all of their hard work.

Reports

Capital Reserve Fund

Mr. Ruf and Mr. Ward gave an overview of the time-line and of the projects completed through the Capital Reserve Fund.

Discussion:

Mrs. Lieberman mentioned that everything looks great and what made things better was our being under budget.

Mrs. Rothman left the room at 8:31 and returned at 8:33.

Field Trips

Dr. Lewis spoke of the funds being put aside in the upcoming budget to support overnight field trips and asked for direction from the Board.

Discussion:

Mrs. Lieberman stated that the Board needs to have a conversation about lifting the hiatus.

Mrs. Rothman asked Dr. Lewis who has contacted her so far in regard to overnight trips.

Dr. Lewis stated that so far the trips involved were the choir, the Supreme Court trip and the guidance department's college road trip. She noted that they need to establish a process for requesting trips.

Mrs. Pierno feels that the trips should be opened to a broad spectrum; she feels that some groups are better at promoting themselves. She mentioned that maybe they can reach out to the principals and chairpersons to come up with ideas.

Mrs. Rothman suggested that even on the elementary level, more opportunities should be explored, and perhaps involve what they are learning in class. She expressed that she was very proud to be lifting the hiatus.

Mrs. Schulman specifically spoke of the overnight trips and how valuable they can be. But she asked, 'how do we choose'?

Mrs. Lieberman feels that they are important, but there is only so much money in the budget. She thinks that it would be nice on the elementary level for the students to go on a special day trip, and that the funds should not go for one grade or group.

Mr. Bettan stated that it was important to understand that the Board did not stop the museum trips. That it was done at the school level and replaced with the moving up celebration. He feels that trips should not be tied with a grade or a group but with the curriculum. He also feels that trips present a big liability for the district and that there should be a policy in place.

Mrs. Lieberman said that there should be a policy in place before September, not just for the students but also for the parents. She feels that there is so much out there for the students to see and enjoy.

Mr. Bettan stated that the budget for this year is completed. He noted that as Dr. Lewis stated, because of the success our students have had in competitions, that perhaps next year we can set aside funds for this purpose.

Science Research

Ms. Gierasch gave an overview on some of the Board Goals.

Ms. Barry spoke of the following: the importance of developing lifelong research skills, working and learning independently, adhering to deadlines, searching and reading at high level sources, writing and editing, the use of technology and integration, presentation skills and how to commutate with professionals in the outside world.

Ms. Carnesi spoke about the implementation of the CCSS aligned to research and how the research component has extended student learning opportunities.

Ms. Gierasch spoke of meeting with students to get feedback on what they can do differently in the Middle Schools. She added that they need a way to 'advertise' to get more students involved in research projects in order to help build a community of learners. She stated that it was not an easy task to blend research and technology; she commended the chairpeople and principals. She also spoke of the partnership with Hofstra.

Discussion:

Mrs. Pierno thanked everyone involved. She stated that it consisted of very difficult work, encompassing a very large area. She asked whether the Middle school students have the skills they need and maybe we can revamp the CEU's in order to align them with the Common Core and with our goals.

Ms. Barry stated that the Middle school students were technologically savvy but there are still pieces they don't understand. She said that they are re-vamping the curriculum across the disciplines.

Mrs. Pierno asked about how the second graders are being taught not just to memorize but to find the answers. She also expressed her thoughts on how many students don't know how to use the public library.

Ms. Carnsi stated that posing the question is almost more insightful than finding the answer.

Ms. Gierasch stated that the public librarians were brought in to speak to the teachers concerning all of the resources available. Many of the teachers did get library card.

Mr. McNamara stated that the public librarians did a great job in advising the teachers as to what resources are available.

Mrs. Schulman stated that most people are not aware of the value of the Research Program, and asked how many students are in the program. She also said that she was pleased at how much re-writing is done and expressed how wonderful it is that the students get to present their papers.

Ms. Barry said that there are 72 students this year in 9th grade and there is a learning curve.

Mrs. Rothman asked what kind of software and programs they are using and what else do they need for the success of the program.

Ms. Barry stated that more SPSS licenses would be useful, but added that they are expensive. She also said that the lack of space is a big issue.

Mr. Bettan thought that it was wonderful that the librarians are involved. He also said that he hopes the students were being told that not everything they read on the internet is true.
