Dear Congressman Santos,

We, the members of the Plainview-Old Bethpage Board of Education, along with the leaders of the Plainview Congress of Teachers, Association of Administrators, Parent/Teacher Association, Teamsters, Superintendent of Schools, and our POBJFKHS Student Government, write to you deeply concerned about your recently filed legislation, H.R. 1095, that seeks to "declare an AR-15 style rifle ... to be the National Gun of the United States." Paramount among our goals as school board members is to ensure the safety of our children and staff. Your proposed legislation to make the AR-15 the National Gun promotes the very weapon which has been often used to cause death and destruction in our nation's schools.

Since the Columbine High School shooting in 1999, over 300,000 students have been touched by gun violence in more than 350 separate school shootings. Indeed, last year alone there were over 50 school shootings, more than any year since Columbine. The mass shootings at the following schools all involved an AR-15-style weapon: Robb Elementary School in Uvalde, Texas on May 24, 2022 (21 dead); Stoneman Douglas High School in Parkland, Florida on February 14, 2018 (17 dead); and Sandy Hook Elementary School in Newtown, Connecticut on December 14, 2012 (27 dead).

Co-sponsoring a bill that glorifies this semiautomatic assault rifle will only serve to glorify what has become a weapon of choice for mass shootings in schools, what should be a sacred place where students and educators feel safe. Instead, we ask you to devote your time and attention to advocating for gun safety, supporting legislation that could help stop the massacre of our children and staff.

We cannot emphasize enough how disturbed and disappointed that this proposed legislation is one of your first acts as our congressional representative. We request that you withdraw as co-sponsor and pledge to vote against such legislation. It is never too late to do the right thing! Let us join together to protect all of our communities and to keep our schools safe.

Resolved, that the New York State School Boards Association support legislation at the state and/or federal level that would reform the current gun laws to strengthen background checks, implementing red flag laws, as well as laws that will restrict guns from those under the age of twenty-one.

Rationale

Since the horrific events at Columbine High School in 1999, school shootings have become an unfortunate recurring event in the United States. Enough is enough.
