Re: Affordable Care Act – Required Exchange/Marketplace Notification to Employees

On March 23, 2010, the Patient Protection and Affordable Care Act (ACA), more commonly referred to as the Affordable Care Act, was enacted into law. A requirement of this legislation is that employers nationwide must provide notification to their employees of the availability of the Affordable Insurance Exchange (the Exchange) now being called the Marketplace.

The notification below is the required Notice of the Marketplace being provided to you in compliance with the Affordable Care Act. Please take time to review this important document.

Exchange/Marketplace Notification to Employees

General Information

To assist you as you evaluate options for you and your family, this notice provides some basic information about the Marketplace and employment-based health coverage offered by your employer.

What is the Health Insurance Marketplace?

The Marketplace is designed to help you find health insurance that meets your needs and fits your budget. The Marketplace offers "one-stop shopping" to find and compare private health insurance options. You may also be eligible for a new kind of tax credit that lowers your monthly premium right away. Open enrollment for health insurance coverage through the marketplace begins in October of each year for coverage as early as January 1st of the following year.

Can I Save Money on my Health Insurance Premiums in the Marketplace?

You may qualify to save money and lower your monthly premium, <u>but only if your employer</u> <u>does not offer coverage</u>, or offers coverage that doesn't meet certain standards. The savings on your premium that you are eligible for depends on your household income.

Does Employer Health Coverage Affect Eligibility for Premium Savings through the Marketplace?

Yes. If you have an offer of health coverage from your employer that meets certain standards, you will not be eligible for a tax credit through the Marketplace and may wish to enroll in your employer's health plan. However, you may be eligible for a tax credit that lowers your monthly premium or a reduction in certain cost-sharing if your employer does not offer coverage to you at all or does not offer coverage that meets certain standards. If the cost of a plan from your employer that would cover you (and not any other members of your family) is more than 9.12% in 2023 and 8.39% in 2024 of your household income for the year, or if the coverage your employer provides does not meet the "minimum value" standard set by the Affodable Care Act, you may be eligible for a tax credit. Note: If you purchase a health plan through the Marketplace instead of accepting health coverage offered by your employer, then you may lose the employer-contribution (if any) to the employer-offered coverage. Also, this employer contribution-as well as your employee contribution to employer-offered coverage- is often excluded from income for Federal and State income tax purposes. Your payments for coverage through the Marketplace are made on an after-tax basis.
