Coronavirus Response and Relief Supplemental Appropriations

<u>Overview</u>



- On March 27, 2020, Congress passed, and the President signed into law, the Coronavirus Aid, Relief, and Economic Security (CARES) Act. The CARES Act provides \$30.75 billion nationwide in the Education Stabilization Fund to prevent, prepare for and respond to the coronavirus;
- On December 27, 2020, the President signed into law the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSA Act). The CRRSA Act provides \$81.88 billion nationwide in a second Education Stabilization Fund to prevent, prepare for and respond to the coronavirus; and
- On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ARP-ESSER) funds, of which USDE must use \$800 million to provide homeless children and youth with wrap-around services and assistance to attend school and participate fully in school activities.

Allowable Uses of Funds



Done

The CARES Act includes funds related to preventing, preparing for and responding to COVID-19.

CARES Act

There are no "set-aside" requirements for these funds.



These funds may be used for the same allowable purposes as CARES Act and ARP, including hiring new staff and avoiding layoffs.

CRRSA Act

The "additional" allowable uses of funds under the CRRSA Act (addressing learning loss, preparing schools for reopening, and testing, repairing, and upgrading projects to improve air quality in school buildings) already are permitted under the CARES Act.

There are no "set-aside" requirements for these funds.

Set-aside: a portion of funds that must be used for a specific purpose that is explicitly identified in the requirements of a grant.

Allowable Uses of Funds

ARP

Districts must <u>set aside</u> at least 20 percent of their total ARP allocation to address learning loss through the implementation of evidence-based interventions, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of COVID-19 on underrepresented student subgroups.

The remaining ARP funds may be used for the same allowable purposes as CARES and CRRSA, including hiring new staff and avoiding layoffs.

The legislation specifically authorizes districts to use ARP funds to develop strategies and implement public health protocols including, to the greatest extent practicable, policies in line with guidance from the CDC for the reopening and operation of school facilities to effectively maintain the health and safety of students, educators, and other staff. Schools may also use their CARES and CRRSA funds for this purpose, although it is not expressly listed in the CARES or CRRSA Act.

Equitable Services with Non-Public Schools

Reporting Requirements

Expenditure Based Reporting

- 1) All purposes for which funds were expended:
 - a) Support Services: Pupil Materials, Supplies and Other
 - b) Support Services: Instructional Staff
 - c) Support Services: General Administration
 - d) Support Services: School Administration
 - e) Technology Related Supplies and Purchased Services; Related Equipment
 - f) Teacher Salaries (regular, vocational, special, other)
 - g) Operation and Maintenance of Plant Support Services
 - h) Food Services
- 2) Full-Time Equivalent (FTE) Positions



Reporting Requirements

Program Based Reporting

- 1) Student Participation and Engagement Remote Learning
 - a) Submission of assignments
 - b) Participation in assessments
 - c) Tracking student logins to online learning platforms
 - d) Participation in individual coaching or check ins
 - e) Participation in email, text or other electronic communication
 - f) Participation in help lines or hot lines for help with remote learning
 - g) Participation in synchronous online classes
- 2) Student Devices Proportion of students with an LEA-provided device
- 3) Student Internet Access
 - a) Mobile hotspots with paid data plans
 - b) Internet connected devices with paid data plans
 - c) District pays for the cost of home internet subscription for student
 - d) District provides home internet access through a district-managed wireless network
 - e) Other

Detailed guidance from NYSED on reporting requirements is forthcoming



Process

ARP and CRSSA Planning and Oversight

The District will work with a Steering Committee to field community input and provide general oversight.

May 10 – Informational presentation to BoE

May 11 – Call for Steering Committee Members (PTA, Central Office, PCT, ASDA and Teamsters)

Steering Committee Meeting Dates – Three meetings by June 4

June 7 – Report to BoE

June–July – Develop and submit grants in consultation with stakeholders
